We are currently looking at ways of setting up a sustainable supply chain:

- 1. Not to use a cascade of subcontractors to make our clothes.
- 2. Favour European sourcing of materials and components. Opt for non-European sourcing only if the alternative is not relevant (economically or technically);

Through an analysis of the product design phases, we have identified a number of levers for action:

- 3. Incorporate recycled materials;
- 4. Anticipate the restriction or banning of certain chemicals;
- 5. Optimise the use of materials and components;
- 6. Include elements at the design stage to increase the product's lifespan: facilitate repair, use components adapted to the product's use, etc;
- 7. Reuse packaging
